

The **Bayou Community Foundation** (BCF) was born in the spring of 2012.

At the BCF, we work to strengthen our local capacity to create a compassionate and sustainable coastal community for generations to come. We achieve this mission through strategic investments in education, workforce development, human services programs, and coastal preservation in Lafourche, Terrebonne, and Grand Isle. BCF conducted a comprehensive community needs assessment in 2013 to understand the challenges we face and to target grants that best address these critical needs.

Giving to the BCF is easy. These steps will get you on your way:

- 1. Decide to Give. Make a contribution now, plan for regular giving, establish it in your will or trust, or direct funds from your family or company foundation to BCF for ease of administration. Tax deductions are earned at the time of your gift, and your financial advisor or accountant can further explain tax-planning benefits.
- 2. Decide What to Give. Almost any kind of asset can be contributed: cash, publicly traded securities, closely held stock, interests in limited partnerships, real estate, life insurance, and private foundation assets. We can also discuss other options with you, such as bequests and charitable trusts.

3. Decide How to Give.
